



## GDPR PRIVACY POLICY

Farmacare S.r.l. as holder of personal data under art. 13 of EU Regulation no. 679/2016 – General Regulation regarding Data Protection (“GDPR”) – in compliance under said obligations dictated by the Privacy Protection legislator, the following is the necessary information regarding how your personal data is handled with regard to method and use of such personal data, also with regard to communication of and diffusion of this data, and the nature of the data in our possession and their conferment.

### 1) HOLDER AND MANAGER OF THE DATA (art. 13, par. 1, lett. a)

The manager of the data collected is the company FARMACARE S.r.l., with legal Headquarters at San Pietro in Casale (BO), Via Antonio Gramsci, 8/10/12/14, Partita IVA 04076870379, legal representative in the person of Mr. Gentileschi Dino, cod. fiscale GNTDNI39H11H501X (hereafter called “Farmacare S.r.l.”)

### 2) DATA SUBJECTED TO HANDLING

- . Identification Data
- . Accounting Data
- . Financial Data

The data of those involved will be conserved/handled for the time necessary to carry on existing relations between the parties and to conform to the relative obligations, and according to the applicable terms of the law (art. 5, par. 1, lett. e).

Data will be stored in written form on paper or electronically, accessible only to encharged and instructed company personnel (list of which is available at the headquarters of the manager), via the use of computerized systems that are adequately updated and protected.

### 3) PURPOSE OF HANDLING DATA (art. 13, par. 1, lett. c)

- a) Operative, management, administrative/accounting, and financial actions
- b) Marketing activities, with commercial information and promotional activities

Data is handled in relation to contractual needs and in order to conform to legal and contractual obligations deriving thereof, and to attain efficient management of sales relations, for our internal controls service, for quality assurance verifications and for customer satisfaction levels.

### 4) LEGAL BASIS OF DATA HANDLING (art. 13, par. 1, lett. c)

The legal foundation for data handling can be:

- Contract – To stipulate a contract or during the pre-contractual phase, we must acquire and handle data as described above, because contrarily, we would otherwise be unable to supply the service/product requested, so therefore handling consensus is not required
- Conforming to an obligation under the law

### 5) OBLIGATORY DATA HANDLING (art. 13, par. 2, lett. e)

The handling of Customer and Supplier data, for reasons of conformity of contractual obligations, constitutes one of such obligations. Any opposition to said data handling results in the practical impossibility to proceed with the contractual relationship.

### 6) AUTOMATED DECISIONAL PROCESSES (art. 13, par. 2, lett. f)

Farmacare S.r.l. does not use automated decisional processes.

- ❖ Subjects indicated by yourselves for instrumental reasons to execute their contract for your account
- ❖ Other subjects that from time to time are necessary to use for legal obligations to execute a contractual or sales relationship

## 8) NON DISCLOSURE OF DATE AND TRANSFER ABROAD

Personal data will not in any case be disclosed to recipients outside the EU, to undetermined recipients, nor will it be transferred abroad.

## 9) DATA STORAGE (art. 13, par. 2, lett. a)

All personal data conferred will be treated in the respect of principles of lawfulness, correctness, transparency, pertinence, proportionality and safety, exclusively with and including computerized and telematic methods, strictly necessary to pursue the above described objectives. In any case, personal data will be stored for a period of time not beyond that which is strictly necessary to the attainment of the objectives indicated.

## 10) RIGHTS OF THE INTERESTED PARTY (art. 13, par. 2, lett. b)
